4. First Aid Measures (Symptoms)

- Skin contact:** May cause severe irritation, redness, and burns. May be absorbed through skin with prolonged or repeated contact.
- Eye contact:** May cause severe irritation, redness, burns and possible corneal injury.
- Ingestion:** May cause severe irritation or burning of gastrointestinal tract and possible mucosal injury.

- Inhalation:** Remove to fresh air and rest. In all cases if symptoms persist, seek medical attention.

6. Accidental Release Measures

Environmental precautions: Do not allow runoff into public waterways.

Clean up procedures: Collect and reuse if possible. Dilute and flush to sewer with large quantities of water if permitted by regulatory authorities or absorb on inert material (sand, clay, etc.) and place into container for proper disposal.
