2. Composition/Information on Ingredients

Ingredients: Sodium Lauryl Ethoxy Sulphate, Coconut Diethanolamide, Fatty Acid Amidoalkylbetaine, Citric Acid Anhydrate, Sodium Chloride.

3. Hazards Identification

Main hazards: Not hazardous.

4. First Aid Measures

Eye contact: Irritation and redness. Rinse well with copious quantities of clean water. If irritation persists, seek medical attention.
Ingestion: Abdominal pain, sickness and diarrhoea. Do not induce vomiting. Give small sips of milk or water to drink and seek medical attention.
Skin contact: Product is designed to be skin friendly.

5. Fire Fighting Measures
